Shri Anil Kamble filed a complaint vide email dated 12.02.2015 regarding recruitment process of IBPS for Probationary Officer (PO) III and Clerical Cadre III for the year 2014-15 before the Court of the Chief Commissioner for Persons with Disabilities.

- 2. The matter was taken up under Section 59 of the Persons with Disabilities Act, 1995 with IBPS, Mumbai and the Department of Financial Services, New Delhi vide this Court's letter dated 18.03.2015 to submit their comments on the complaint.
- 2. Department of Financial Services vide letter dated 10.04.2015 asked the Chairman, IBPS to get examined the representation of the complainant thoroughly and a suitable reply may be sent directly to the complainant and the CCPD under intimation to them.

- 3. IBPS vide letter dated 30.03.2015 intimated that their organization is a test conducting agency acting as per the mandate given by the participating agencies for selection of personnel to fill reported vacancies. So far as the case of the complainant is concerned, although he qualified in the written examination and interview, yet his status is un-allotted or unsuccessful as he scored less than the minimum score secured by the last candidate of his category.
- 4. The reply received from IBPS was sent to the complainant vide letter dated 27.04.2015 for submission of his comments/rejoinder in the matter. The complainant vide his email dated 30.04.2015 intimated that he is satisfied with the reply of IBPS and would like to withdraw the case.
- 5. As the complainant is satisfied with the reply of the IBPS and has desired to withdraw the case, the Court of CCPD agreed to the same and decided to close the matter.
