The above named complainant Shri Menish Gautam had filed a complaint dated 30.06.2015 under the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995, hereinafter referred to as the Act regarding discrimination with OH candidates in the roster by Delhi University and its colleges.
- 3. The matter was taken up with the respondent vide letter dated 23.07.2015 under Section 59 of the Act and upon considering the respondent's letters dated 01.09.2015 and 08.03.2016 and complainant's e-mail dated 15.10.2015, it was decided to hold a personal hearing in the matter therefore, the case was listed on 06.07.2017.
- 4. During the hearing, representative of the respondent submitted that the complainant in this matter, has filed a statement in similar Case No. 7334/1014/2016 stating that the said matter is pending before the Hon'ble High Court and therefore, proceedings in this Hon'ble Court may be dropped as the matter in the present case is already sub-judice.
