**ORDER**

Vide Record of Proceedings dated 10.02.2016, the respondent was directed to furnish the following information to this Court by 25.02.2016 positively:-

- (i) details of vacancies filled since 01.01.1996 in the proforma supplied during the course of hearing on 28.01.2016.
  - (ii) certificate of the Liaison Officer certifying that the Roster has been maintained from 01.01.1996 as per DoP&T's instructions.
  - (iii) copy of advertisement for filling up the posts reserved for persons with disabilities.
  - (iv) justification of gap of filling up of vacancies in VH, HH & OH category.
2. Ministry of Water Resources, River Development & Ganga Rejuvenation vide letter No. F-12011/5/2014-Coord dated 12.04.2016 furnished the information in respect of Ministry (Proper) and the following Organizations under the Ministry, as under:-



3. On perusal of the information, it was found that the information furnished is not satisfactory and is also not clear and, as such, the matter was again listed for hearing on 05.06.2017.

4. During the hearing on 05.06.2017, the representatives of the respondent Ministry requested the Court to conduct another one day Workshop on Maintaining of Roster System on 3% reservation for persons with disabilities. Not acceding to the request of respondent, this Court directed that their Ministry may organize such a workshop at their own level. The Court further directed the Ministry to seek the help of the representative of the Ministry, Shri Aman Bishnoi, Assistant Section Officer, who attended the One Day Workshop on Maintenance of Reservation Roster in preparing the reservation rosters as per the provisions of DoP&T's O.M. No. 36035/3/2004-Estt.(Res) dated 29.12.2005 and furnish the same to the Court within a period of three months from the date of receipt of this Court Order with a copy of the same to be provided to the complainant as well.

5. The Court accordingly disposed off the matter.
