ORDER

Vide Record of Proceedings dated 10.02.2016, the respondent was directed to furnish the following information to this Court by 25.02.2016 positively:-

- (i) details of vacancies filled since 01.01.1996 in the proforma supplied during the course of hearing on 28.01.2016.
- (ii) certificate of the Liaison Officer certifying that the Roster has been maintained from 01.01.1996 as per DoP&T's instructions.
- (iii) copy of advertisement for filling up the posts reserved for persons with disabilities.
- (iv) justification of gap of filling up of vacancies in VH, HH & OH category.

3. Ministry of Environment, Forest and Climate Change vide letter dated 15.02.2016 intimated that the copies of reservation rosters for persons with disabilities in respect of Zoological Survey of India, Kolkata and Botanical Survey of India, Kolkata subordinate office of their Ministry are enclosed but they were found not enclosed with the letter.

4. Further, Ministry of Environment, Forest and Climate Change vide letter dated 28.03.2016 filed the information obtained from the following Divisions/Organizations of their Ministry as under:-

5. As the reservation rosters submitted by the Ministry of Environment, Forest and Climate Change were not maintained as per DoP&T's instructions and even the information regarding details of vacancies filled since 1996 was not correct, the matter was listed for hearing on 24.05.2017.

6. During the hearing on 24.05.2017, both the complainant and the respondent were absent despite the fact that the Notice of Hearing was sent by Speed Post on 25.04.2017. The Court took serious note of the same. After going through the record placed on file, the case is disposed off with the following directions to the respondent:-

- (i) Prepare the Reservation Roster w.e.f. 01.01.1996 as per DoP&T's instructions.
- (ii) Compute the backlog of vacancies and fill the vacancies by conducting Special Recruitment Drive in a time framed manner.
- (iii) Advertisement should be made as per para 25 of DoP&T's O.M. No. 36035/3/2004-Estt. (Res.) dated 29.12.2005 and subsequent OMs issued by DoP&T from time to time in this regard.
