ORDER

The above named complainant Dr. Nitesh Kumar Tripathi filed an e-mail dated 18.11.2015 under the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995, hereinafter referred to as the Act regarding non implementation of provisions of Persons with Disabilities Act, 1995 by NIT, Karnataka.

- 2. The complainant in his complaint submitted that National Institute of Technology, Karnataka has published an advertisement for Doctors & various other posts and the advertisement is not showing exact number of seats reserved for persons with disabilities. He has requested to direct the respondent to provide full exemption from the payment of application fee, 10 years age relaxation, extra time during examination, travel expenses to attend interview along with an escort, disabled friendly environment during the interview and to also conduct the Special Recruitment Drive for filling up the backlog vacancies for persons with disabilities.
- 3. The matter was taken up with the respondent vide letter dated 29.06.2017 under Section 59 of the Act. After considering the respondent's letters dated 10.12.2015 & 20.09.2016 and complainant's e-mail dated 23.12.2016, it was decided to hold a personal hearing in the matter therefore, the case was listed on 19.07.2017.

- 4. During the hearing, representative of the respondent submitted that they have mentioned in the advertisement that SC/ST/PwD candidates called for Written Test and/or Interview shall be reimbursed as per Govt. of India norms for the to and fro journey by the shortest route from their correspondence address/working place in India subject to production of ticket (s) & proof of working/residence in case they are travelling from the place of working in India and self attested documents in support of eligibility. He further submitted that they have also provided reservation for Persons with Disabilities in the advertisement. They have also submitted the copy of the certificate of the Liaison Officer certifying that the Roster has been maintained from 01.01.1996 as per DoP&T's instructions and also produced copy of the reservation roster for PwDs. He has also informed that at present, there is no Director in their Institute; therefore recruitment process has been kept pending.
- 5. After hearing both the parties, the case is disposed off with the direction to the respondent that whenever the new Director joins the post, the recruitment process should be initiated immediately and with an intimation in advance to the complainant.
